Ready to help? Just follow these simple steps:

- First, know that you don't need to wait until your current registration or license is due to precommit. During the pre-commitment phase, any car owner in the state can sign up for the PROTECT OUR BIRDS tag at any time!
- 2. Second, know that signing up for a pre-commitment **does not oblige you to get a plate or to put one on your vehicle.** When the plates go into production, you'll get an email with instructions on how to pick yours up, but if you change your mind between now and then, that's okay, too. The important thing is to help us reach the 1,000 vehicle requirement threshold needed to put the plates in production.
- 3. If you're ready to start, collect the relevant information for each vehicle (car/truck/motorcycle) you wish to include in this request. That includes each vehicle's make, model, VIN, and *current* license-plate number—your registration is probably the best way to find that info. And remember, you can enter more than one vehicle per form as long as they have the same owner; in fact, the more you enter, the more you help Audubon!
- 4. Fill out the attached form ("Commitment To Purchase Application"), referring to the provided example for guidance, if necessary.
- 5. On the form, be sure to include the name of the vehicle's **owner** or **co-owner**, as well as the owner's **mailing address**, **city**, **state**, **ZIP**, **county**, **email**, and **telephone number**. You'll also need to provide vehicle information for *each* vehicle you're including in your pre-commitment. While there isn't a space for it on the form, you can add additional current license tags below the provided box.
- 6. You can leave NO. COMMITMENTS THIS APPLICATION and FEES REMITTED **blank**. We'll take care of those for you!
- 7. Personalizations (like, say, **BRDNRD**) are free on Alabama distinctive tags, but you can't reserve your personalization until the tags are in production. If you plan to take advantage of that option, simply check "yes" in the WILL THIS PLATE BE PERSONALIZED? box. Otherwise, check "no."
- 8. Choose whether or not you're okay with releasing your name and information to us—we'd love to reach out and thank you once the plates are here, but if you'd prefer to opt out, that's okay too!
- 9. MOST IMPORTANTLY, you (the owner) must sign and date the form in two separate places: on the CERTIFICATION line ("Signature of Applicant") and also on the first of the POWER OF ATTORNEY lines ("Signature of Vehicle Owner/Lessee"). The certification signature vouches for the information provided, while the power-of-attorney signature gives us the limited legal ability to submit this form on your behalf.
- 10. Review your info for accuracy, then send your form to us. Once we receive it, we'll sign on the APPOINTEE line, pay the \$50 fee on your behalf, and submit your paperwork to the State.
- 11. To get your form to us, either a) scan or take a legible photograph of your document and email it to info@alaudubon.org, or b) mail it to us at ALABAMA AUDUBON, 3720 Fourth Avenue South, Birmingham, AL 35222. If you live in the Birmingham metropolitan area, we may also be able to arrange for pick up or to provide you with a location for drop off. Email info@alaudubon.org for details.
- 12. The final step is to spread the word! Most Alabama tag campaigns fail to reach the 1,000 vehicle requirement, but with your help, we're confident the PROTECT OUR BIRDS tag can make it. And with Audubon paying for the pre-commitment, you have nothing to lose by signing up! Help us make this tag a reality today—check out our online FAQ (alaudubon.org/tag-faq) for more details.
